The performance of the service for which nominees are being recognized **must have occurred after age 60**. They must have completed the service or special efforts for which they are being recognized in Miami-Dade or Monroe County. They need not reside in either of these counties currently. Awards will be presented on November 14<sup>th</sup> at Jungle Island.

Persons may be nominated for a Positive Living Award in one of the following categories:

| <b>Corporate &amp; PublicService</b>           | exemplary volunteer effort/leadership through corporate/professional position or job and/or public service and leadership in the community                        |
| <b>Education/Mentoring</b>                     | outstanding effort, time, energy, resources or leadership by mentoring others or helping to advance individuals, groups or institutions in the field of education |
| <b>Environmental</b>                           | leadership in improving protection of the environment   |
| <b>Faith/Interfaith</b>                        | outstanding effort to improve life through leadership of or involvement in the faith-based community  |
| <b>Health Care</b>                             | leadership in developing, expanding or safeguarding quality available and affordable health care  |
| <b>Inter-Generational</b>                      | exceptional dedication to developing or strengthening ties between different generations  |
| <b>Legal Service</b>                           | exemplary use of his/her experience in the legal community to promote justice and safeguard the rights of individuals   |
| <b>Philanthropy</b>                            | exceptional dedication to not-for-profit organizations by providing financial support to not-for-profit organization(s)   |
